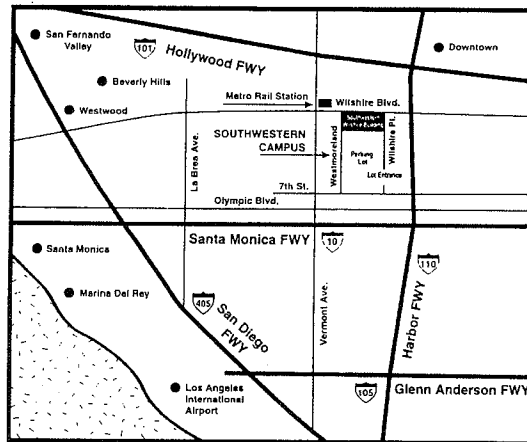

*Southwestern University School of Law is located three blocks east of Vermont Ave. between Wilshire Blvd. and 7th St.*

- *From the Hollywood Freeway (101), take the Vermont exit and head south. Continue south on Vermont to Wilshire Blvd. Turn left on Wilshire, then turn right on Wilshire Place and enter the parking lot through the visitor's entrance on the right.*
- *From the Santa Monica Freeway (10), take Vermont exit and head north. Continue north on Vermont to 7th St. Turn right on 7th St., then left on Wilshire Place and enter the parking lot through the visitor's entrance on the left.*
- *From Los Angeles Airport, take the 105 Freeway east to the 110 Freeway north. Exit Pico Blvd. (exit the 110 as if you are going to the 10 freeway and the Pico exit is on your left). Take a left on Pico going west to Vermont Ave. and turn right onto Vermont. Continue north on Vermont to 7th St. Turn right on 7th St., then left on Wilshire Place and enter the parking lot through the visitor's entrance on the left.*
- *From downtown Los Angeles, take Wilshire Blvd. west. Turn left at Hoover St., right on 7th St., and right on Wilshire Place. Southwestern's parking lot entrance is on the immediate left. (From downtown Los Angeles, you may also take 7th St. west. Then make a right on Wilshire Place.)*
